ADDITIONAL FEES FOR NEW STUDENTS JOINING DOMUSCHOLA INTERNATIONAL SCHOOL

- 1. Matriculation Fee - Php 25,000 for Local / Php50,000 for Foreign** - one-time, non-refundable fee from Kinder to High School payable upon enrollment.
- 2. Capital Development Fund (CDF) - Php50,000** - The CDF is a one-time only fee payable upon enrollment. No interest will accrue on CDF. The CDF is **refundable** once the child withdraws or graduates from the school. CDF refund will be processed within 45 days from date of formal withdrawal and upon completion of school clearance.
